REPORTS TO PRESBYTERY (Items 20 – 22)

20. Grace-Trinity Community Church, Minneapolis, MN: Position Description for Interim/Temporary Pastor (half-time) for David Liddle

- a. To **report** to Presbytery that the Committee on Ministry has concurred with the action of the Session of Grace-Trinity Community Church, to approve the position description for an Interim/Temporary Pastor, half-time, for a period of 2 to 3 months, beginning February 1, 2012, according to the following terms:

Salary	\$30,000 per year
Housing	None
Pension, Medical	None

- b. To report to Presbytery that the position of interim/temporary pastor for Grace-Trinity Community Church will be filled by the Rev. David Liddle.
- c. To **recommend** to Presbytery that The Rev. David Liddle be appointed Moderator of the Council of Elders effective February 1, 2012.
- d. To report that The Rev. Scott Stapleton will conclude his work as Pastor of Grace-Trinity Presbyterian Church January 31, 2012.

21. First Presbyterian Church, Howard Lake, MN: Terms of Contract for Full-Time Temporary Pastor: The Rev. Kenneth Ribe.

- a. To **report** to Presbytery that the Committee on Ministry has concurred with the invitation of the Session of First Presbyterian Church, Howard Lake, MN, to The Rev. Kenneth Ribe to serve as full-time temporary pastor, effective March 1, 2012, to February 28, 2013, according to the following terms:

Cash Salary and Housing	\$45,000 (includes \$2,500 Housing)
Continuing Education allowance	\$1,200 per year
Continuing Education Leave	2 weeks, cumulative over 3 years to 6 weeks
Pension	Full
Automobile Allowance	IRS rate, vouchered up to \$1,500.
Contracted travel expense @\$.45	Up to \$6,912.
Professional Expense	Vouchered up to \$500.00

- b. To recommend to Presbytery that The Rev. Kenneth Ribe be appointed moderator of the session of First Presbyterian Church, Howard Lake, effective March 1, 2012.
